NOTE: Pension Documents – Each document contained within each NARA file noted above has been photographed. Not every document has been annotated below, but only those with family history data are summarized.

General Affidavit -- Dated 20 December 1879 of Daniel Heinbauch a resident of Bronson, Branch Co., Michigan stating his reasons for applying for a pension. It reads: "... he is the identical Daniel Heinbauch who was enrolled on the 20day of January A. D. 1862, in Company "B" 1st Regt. of Mich. Infant., Vol. commanded by William H. Frey & was honorably discharged at Camp in the Field, Va., on the 28 day of January 1865. That his personal description is as follows: Age, 42 years; height 5 ft 7 in.; complexion, fair; hair, light; eyes, blue. That while a member of the organization aforesaid, in the service &in the line of his duty, at Annapolis Junction, Md. In the fall of 1861 & winter of 1861-2 claimant contracted Chronis Diarrhea & on or about Sept. of 1862 said disease of Chronic Diarrhea brought on & merged into Bleeding Piles. That he was sent to Camp Hospital Va. where he remained about one day & night but did not receive any treatment then asked for & rec, permission to go back to his regiment. That he has not been employed in the military or navy service other than as stated above. That since leaving the service this applicant has resided in Bronson."

General Affidavit -- Dated 20 December 1897 of John G. Stepper a resident of Coldwater, Branch Co., Michigan in support of the claim of Dan'l Heinbauch. It reads: I was Capt. Co. "B", 1st Mich. Inf. 1. I have known claimant from a boy up and certify upon honor that at the time claimant enlisted in Co. "B" of said Regt. He was a sound healthy man free from Chronic Diarrhea or Piles. 2. That in the fall of 1861, and in the winter of 1861-2 in camp at Annapolis Junction, Md. Claimant contracted Chronic Diarrhea in the line of duty. 3. That said disease in my judgement was brought upon claimant by army diet, change of water & Climate. That said disease of chronic Diarrhea brought on & merged in Bleeding Piles about September of 1862, on the march towards Gettysburg, in Md., by Harpers Ferry or wear that time. The reason I know is that he had been detached by my consent as a Regimental teamster because his Piles came down so that it was hard for him to duty on march. I was wounded at the time and rode with him in the wagons. He was troubled with that disease at the time he was discharged. 4. I have seen him frequently since he was discharged & have often talked with him about his piles, and have mirariably(sp) been told by him that he was still seriously troubled with them."

Request of Department of the Interior, Pension Office to the Adjutant General, dated 19 March 1881, to report on the service and disability in the case of Daniel Heinback.

Return from War Department, Adjutant General's Office to Commissioner of Pensions, dated 27 April 1881, reporting on Daniel Heimbach's service. It reads as follows: "Company B, 1st Regiment Mich Volunteers was enrolled on the 20th day of Jany, 1862, at Burr Oak, and mustered in Jany 30th / 62 at Annapolis Junction Md. A Pvt for 3 years – Roll Feb 28th / 62 report him present. Reported present to Aug 31st / 62 – Mustered out on Det muster out roll Jany 28th 65 near Petersburg Va a Pvt. The records of this office furnished no evidence of alleged disability."

Surgeon's Certificate – State: Michigan; County: Hillsdale; Post Office: Hillsdale; Date: 8 Aug 1881; Name: Daniel Heinbauch; Rank: Pvt.; Unit: B, 1st Mich V; Height: 58/12; Weight: 132; Complexion: ; Age: 42; Pulse: 100 Strong; Respiration: 19; Examining Surgeon: John W. Lally; Reads as follows: "... an applicant for an invalid pension by reason of alleged disability resulting from chronic diarrhea & piles. In my opinion the said Daniel Heinbauch is three eights 3/8 incapacitated for obtaining his substance by manual labor from the cause stated above. ... It is my belief that said disability did originated in the service ... Very little trouble with diarrhea if he is careful of diet and does not over do. One of the worst cases of piles I have had the pleasurer of examining. Several layers of tumors ... Says they bleed much. His drawers show it. Complaining of much joint weakness in the back."

Request of Department of the Interior, Pension Office to the Surgeon General, dated 31 Jan 1882, to report on hospital treatment in the case of Daniel Heinbach.

Return from War Department, Surgeon General's Office to Commissioner of Pensions, dated 21 May 1882, reporting on Daniel Heinbach's service. It reads as follows: "There are no records of the within named Regiment on file in this office."

Letter from Department of the Interior, Pension Office to _John G. Steffer, dated _24 March 1884, asking: For information about Daniel Heinbauch. "... please inform this office of the exact date at which claimant contracted diarrhea or how soon after enlistment he was afflicted with it."

Letter from Daniel A. Heimbauch, Burr Oak, St. Joseph Co., Michigan to Commissioner of Pensions, dated 30 March 1884. It reads as follows: "Now I will make my Statement just as near as I can. My Diarrhea and piles commenced when we were in front of Petersburg or about that time. The 8 of July 1864 as near as I can remember and I went to the Division Hospital. Did not stay But one night then went back with my regiment and reported for Duty. I thought I Could not stan it in the hospital. Now since that time I have not been right. I can work some of the time, But some of the time in hot weather I can hardly do anything. Now then I will say right here that the Doctors did not give me any medicine, But I went to a Hospital Wagon and got some Caster oil and took that along now after I got home. I Doctored with Doctor Lovejoy until he died about two years and he did me no good. Since that time, I have Doctored myself and by using tollour (sp) and such things and Being Careful what I eat I am able to work about two thirds of the time. I now have all the proof that you ask for. I have forwarded Before now I will try to send it again then I will not do anymore.

Nor pay no more money. I am poor and got a Big family the support to support and it cost me Some money 500 that I paid A. J. McGowin then it cost me 300 dollar to go to Hillsdale to be examined and now I have Sent Sober & Co one dollar more and the papers and County Seat have Cost me some more now. I ghot(sp) to pay the some(sp) out again to get these papers. All right now I served honest for thin(sp) government and this is the best that I Shall trouble my head no more here after. There is men right here in the neighborhood that got a pension and they I were not in the service half as long as I was.

Now I will Send this By Mail tomorrow with the letter you wrote me and I will get the other papers fill out soon as I can and send them.

Yours with respect."

Letter from John G. Steffer, Coldwater, Michigan to Commissioner of Pensions, dated 1 April 1884. It reads as follows: "In Regards to Daniel Heimbauch being Afflicted with Piles and the Diarrhea came on him I think was June or July 1864. We was in front of PetersBurg(sp) V. A. at the time he went to the Hospital and staid one or two days then came back again. How much the Dockter(sp) treated him in Camp I hardly can say. Docktor(sp) Hoeberd was our Surgeon and Fuller Assistant S. I was well acquainted with him before the War as

we lived near together at that time and he was all right and wp to the Summer of 1864. This is all Say excepting that Heimbauch was a good faithful Soldier as long as he was with me. Yours Respectfully,"

General Affidavit -- Dated 3 April 1884 of Daniel Heimbauch a resident of Bronson, Branch Co., Michigan in support of his claim. It reads: "... tat at the time he was taken sick with Diarrhea + Piles along somewhere about the middle of August 1864 as near as he can remember that he was sent to what is called the division hospital in front of Petersburg V. A. and that he only staid one night and the reason why he sis not stay longer was that as the Hospital was filled up with wounded and the noise made by the wounded and the ??? ??? of being present and seeing them suffer was more that I could stand and I thought I had rather take my chance of life with my Regiment than in the Hospital and I went back to my regiment and all the medicine I took after that was a little Caster Oil that I procure myself up to the time of my discharge. I worked a light work a part of the time after was taken sick taking care of Colonel Wm. A. Throop Horses. That since my discharge the only Physician that has treated me was Dr, Lovejov of Burr Oak and that he treated me when I just came home from the army and is now dead and has been dead for the last 12 years or more and that since his death he has treated himself as best he could using oils + the like and that thereafter he is unable to procure and medical testimony before ??? after discharge."

General Affidavit -- Dated 5 April 1884 of Emanuel Fry a resident of Burr Oak, St. Joseph Co., Michigan in support of the claim of _Daniel Himebauch. It reads: "... for the last thirty years, except the time said Heimbauch was in the service of the United States during the rebellion and he says that he knows that said Daniel Heimbauch was a strong healthy man and boy up to the time of his enlistment in said service and free from Chronic Diarrhea + Piles. That he has worked with and together a great part of the time since his discharge from the service joining farms in Co. a part of the time and he says that that Daniel Heimbauch has been trouble with Chronic Diarrhea and Piles each year since his discharge to such an extent that a large part of the time he is unable to do any kind of hard labor and a part of the time he is not able to do anything and that he should say that his disability was such that he would not be able to do manual labor more than of half of his time."

General Affidavit -- Dated 5 April 1884 of Dr. Harvey Loomis a resident of Burr Oak, St. Joseph Co., Michigan in support of the claim of Daniel Heimbauch. It reads: "… that he has practiced medicine in Burr Oak for the past thirty four years

and he was the family physician of the Father of Daniel Heimbauch for years and he knew the said Daniel Heimbauch at the time he enlisted in the service and at that time he was a strong healthy Boy as he believes and says if he had had Chronic Diarrhea or pies he would have known and that he believes that at the time he was strong and healthy..."

General Affidavit -- Dated 5 April 1884 of Jerome B. Millman a resident of Burr Oak, St. Joseph Co., Michigan in support of the claim of Daniel Hiembuch. It reads: "... says that he was well acquainted with Daniel Heinbauch ... from boyhood and has worked with him a great deal before his enlistment in war of rebellion and knows that up to the time of his enlistment he was a strong healthy boy and free from Chronic Diarrhea and Piles. That since his return from the army he has worked for me at different times about every year since his discharge and that at all times he has complained of disability from Chronic Diarrhea and Piles and I have lived neighbor to him and worked with him frequently and know that he is troubled with said diseases and has been troubled each year with them since discharge so much so that not able to perform manual labor more than one half of his time and then only with great exertion ..."

General Affidavit -- Dated 9 December 1885 of John Sager a resident of Bronson, Michigan in support of the claim of Daniel Hiembaugh. It reads: "... I am 60 years of age; I am a near neighbor of the said Daniel Hiembaugh and have been for 35 years past; have known said claimant during all this time; Knew the said Daniel Hiembaugh prior to the war of rebellion and previous to his enlisting into the U. S., service, to be a hard working man, a man of good physical health , have worked with him a great deal previous to his entering the U. S. service; have worked with him some since A. D. 1865, when the said claimant has been able to work which has been but a very little of the time and know from my own personal knowledge that he is a man of very poor health, unable to follow his occupation – that of a farmed which is also my occupation; I know that the said Daniel Heimbaugh has no farm of his own nor no property + and is unable to get a living for himself and family by manual labor; during all of my acquaintance with said claimant , I have known him to be an honest man, a truthful person and a reliable citizen. ..."

General Affidavit -- Dated 3 March 1886 of Joshua Hawkins a resident of Medicine Lodge, Barber Co., Kansas in support of the claim of Daniel Himbaugh. It reads: "... I am 44 years of age; I was well and personally acquainted with the said Himbaugh prior to the war of the Rebellion we enlisted together; both of us

enlisted in above named Co. and Reg't.; were near neighbors at the time; I knew that said Himbaugh to be a man prior to the war, of good, sound physical health; during the time that we served the U.S. in said war, I often "bunked" with said Himbaugh claimant; I knew that said Himbaugh to be in good health until we were engaged in taking up the Weldon Railroad in Va., during the month of August, A. D. 1864, at which time and place we both worked very hard, lifting and carrying away Railroad Iron, etc. It was at this place and at this time that I first heard said Heimbaugh Claimant complain of his health and I remember that he complained of having piles and diarrhea, and that the said Himbaugh there and then was excused from service regarding said Railroad work and was sent to take care of and see to Colonel Throop's horses; I afterwards saw claimant once or twice every week and being formerly neighbors and feeling exceedingly friendly with him I would often ask him how he felt and we would talk together in regards to Himbaugh's diseases or afflictions. I further certify that I after saw the said Claimant after we had received our discharge from said U. S. Service, as I lived quite near him – just across the State line, I living in Indiana and Claimant in Michigan – about six miles apart; we lived this wise for about three years after the service of the U. S. as stated above; during these three years I knew Claimant to be still troubled with piles and diarrhea; I have not see said Himbaugh since A. D. 1868 of A. D. 1869. ...,

Regimental Reunions and Exercises

The following gives brief description of the several monuments erected, size of same, where located and the inscriptions they bear:

FIRST INFANTRY.

The First Michigan Infantry monument is upon a large rock south and east of Peach Orchard and midway between monuments of the One Hundred and Eighteenth Pennsylvania Volunteer Infantry on the right and the Twenty-second Massachusetts on the left, facing southwest to the right and front of the Wheat Field. The monument is four feet square at base, ten feet and ten inches in height, of Westerly granite. On the main die is a bas relief representing two standing guns, arranged picturesquely with cartridge box, canteen and cap. Upon the first base is the State coat of arms in bronze, surrounded on the outer edge by the following sentence: "Erected by the State of Michigan to her martyrs and heroes who fought in defense of liberty and union;" upon the second side is the name of regiment, brigade, division and corps; a belt cut in relief and upon the right and left of die polished corps badge. At the rear of the die is a raised and polished panel upon which is cut the following inscription:

"First Michigan Infantry, first brigade, first division, fifth corps, mustered in at Detroit, Mich., May 1, 1861 for 3 months; mustered in at Ann Arbor, Mich., August 17, 1861, for 3 years; re-enlisted as Veterans February 20, 1864, mustered out at Jeffersonville, Ind., July 9, 1865. Total enrollment, 2,144 officers and men. Killed in action, 12 officers, 106 men; died of wounds, 6 officers, 32 men; died of disease, 1 officer, 95 men; total, 252. From the first to the last. Early into Virginia and capture of Alexandria, May 24, 1861, to Appomattox April 9, 1865. Participated in 54 skirmishes and general engagements. The monument marks the

Capt. Clinton Spencer of Lansing spoke as follows:

Address of Capt. Clinton Spencer.

Comrades of the 1st Michigan Infantry;

Conflicting emotions swell our hearts as we recall the events of more than a quarter of a century ago, which occurred on this sacred spot. Many of the comrades of that day yielded up the greatest sacrifice that it is possible for patriots to make in defense of the most vital principle that underlies our national existence. On this memorable field, which marks the highest tide in the flood of treason, their surviving comrades, in behalf of the State of Michigan, with loving hearts dedicate to their memory this monument, which shall be for the guidance and instruction of those that come after us, that the integrity of the National Union will ever be protected to the last extremity by the loyal sons of the whole country. We harbor no feeling of bitterness or revenge towards the then brave foes, who made these silent sentinels willing martyrs in defense of the right, and we gladly join hands with them in every good work to develope and strengthen our great commonwealth. We believe it to be our solemn duty, here above their hallowed dust to proclaim and reiterate, that disloyalty to the old flag was, is, and always will be, TREASON, deep, dark, and damnable, and the survivors of the Old 1st Michigan Infantry do not believe in palliating or shading in the least degree that definition of the term. If so, what mockery to mark the place where heroes fell. What lesson would it teach the sons of the North and South if we say that the other side simply erred in their construction of the Constitution? No, no; words are cheap. Let us make this no meaningless ceremony, and let us let the world know that we fought this great battle in defense of a righteous cause, and that the blood

Comrades, we salute our dead, and may the God of battles help us so to live that when we shall be mustered into the ranks of the grand army on the other shore, we may prove worthy of a place in the company of those whose devotion to their country made them martyrs of liberty and loyalty to the National Union.

A letter from Maj. G. C. Hopper of Detroit, regretting his absence, was heartily cheered by the boys. No member of the organization is held in warmer remembrance than the Major, and always ranks as the "regimental favorite." Cot. Abbott was elected President and Geo. H. Van Antwerp Secretary for the ensuing year. East Saginaw was chosen as the place, and June 27 the time for the next reunion.

REGIMENTAL HISTORY

American Civil War Regiments, The Union Army, vol. 1. [This is a history of the regiment during its entire service during the war. The portion of time from enlistment date to discharge of this soldier is highlighted in *italics*.]

MICHIGAN FIRST INFANTRY (Three Months) – Regimental History: In compliance with President Lincoln's requisition upon the State of Michigan for military aid to uphold the Constitution and maintain the Union of the States, Governor Austin Blair issued a proclamation, dated April 16, 1861, for one regiment of Infantry to be mustered into the U. S. service.

At this date there were a number of independent military companies in the state possessing military knowledge from long practice and study, and ten of these companies were accepted to form the first regiment. These companies were designated at their home stations as the "Detroit Light Guard," "Jackson Greys," "Coldwater Cadets," "Manchester Union Guard," "Steuben Guard," "Michigan Hussars," "Burr Oak Guard," "Ypsilanti Light Guard," "Marshall Light Guard" and "Hardee Cadets." Orlando B. Wilcox was appointed Colonel of the regiment, and the companies reported to him at Detroit with the least possible delay.

The organization of the regiment was completed April 29, and was mustered into the service of the U. S. May 1, 1861, with an enrollment of 798. The president had called for these troops to serve three months, and the following field and staff and line officers were elected: Colonel, Orlando B. Wilcox, Detroit. Lieutenant Colonel, Loren L. Comstock, Adrian. Major, Alonzo F. Bidwell, Coldwater. Surgeon, William Brodie, Detroit. Assistant Surgeon, Cyrus Smith, Jackson.

The equipment was thorough and complete and had been pushed with such vigor that the regiment was supplied with uniforms and armed and ready for instant service when it left the state, May 13, and was the first regiment from a western state to reach Washington, where it arrived May 16. The regiment crossed Long Bridge and took possession of Alexandria, Va., May 24. The first serious battle of the war was at Bull Run, Va., where the First proved its metal as a fighting regiment and was hotly engaged in that desperate contest, losing heavily in killed, wounded and captured. The regiment returned to the state at the expiration of its three months' term of service and was mustered out Aug. 7, 1861.

The regiment was immediately reorganized for three years' service, at Ann Arbor, with 960 officers and men, and started for Virginia Sept. 16. The regiment took part in the Peninsular Campaign of 1862, under General McClellan, serving in the First Brigade, First Division, Fifth Army Corps. It fought gallantly at Mechanicsville, Gaines's Mills, Peach Orchard, Savage Station, Turkey Bend, White Oak Swamp and Malvern Hill.

After the Peninsular Campaign it was assigned to Fitz John Porter's Corps where it was desperately engaged at Second Bull Run, Aug. 30, 1862, with the other regiments of the brigade and sustained a fearful loss under the murderous fire of the enemy's masked batteries.

The regiment took part in the bloody battles of Antietam, Fredericksburg and Chancellorsville, and reached Gettysburg, Pa., July 2, 1863, in time to bear an active part in one of the hardest and most historic battles of the war. It was engaged in active duty, with frequent contacts with the enemy, until Feb., 1864, when 212 of its members re-enlisted and were furloughed for thirty days to visit their homes in Michigan.

The 10th of April, 1864, the regiment reassembled at Beverly Ford, Va. It took an active part in the campaign of 1864 and was engaged at Allsop's Farm, Spottsylvania, Nye River, North Anna, Jerico Mills and Tolopotomy. It crossed the James River June 16 and arrived in front of Petersburg the 18th, and was engaged in a desperate encounter with the enemy at Poplar Grove Church. The regiment was continuously employed, either throwing up fortifications or fighting the enemy, until Feb. 5, 1865, when it started on the campaign around Richmond, marching and fighting until the surrender of Lee's army at Appomattox Court House.

After the surrender the regiment proceeded by rail to Louisville, Ky., where it was mustered out July 9th and returned to Jackson, Mich., on the 12th, where it was paid off and disbanded.
